## Introduction

**The Silicon Valley Pain Index is an annual report designed to:**

- 1) Provide an efficient, digestible, and current<sup>1</sup> quantitative overview of structured inequalities to inform practice and policy in Silicon Valley.<sup>2</sup>
- 2) Serve to measure and reflect on Santa Clara County's performance as a "human rights county,"<sup>3</sup> which it declared in 2018 in accordance with the International Bill of Human Rights<sup>4</sup> and in accordance with the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW).<sup>5</sup>
- 3) Ignite conversation and collaboration between students, faculty researchers, community members, and policymakers in addressing inequalities and advocating for human rights.

## Historical Context and Guiding Principles of the Silicon Valley Pain Index

The first Silicon Valley Pain Index (SVPI) was inspired by Professor Bill Quigley's Katrina Pain Index,<sup>6</sup> which followed the devastating 2005 hurricane, and the 2020 national Black Lives Matter<sup>7</sup> protests following the police murders of George Floyd and Breonna Taylor in the early months of the COVID-19 global pandemic. The first reports were spearheaded by Scott Myers-Lipton, Professor Emeritus, Sociology. Dr. Myers-Lipton led the development and the expansion of a team of faculty and student researchers for the first five years and has continued to provide leadership and consulting for the current 2025 report. In its sixth year, the report underwent leadership changes and was taken over by Dr. Anji Buckner-Capone, Department of Public Health. Under her leadership, the SVPI Report continues to be a reliable source of data detailing systematic inequalities that harm the quality of life for people who live, work, and play in our communities.

In the SVPI, pain is representative of both personal and community distress or suffering, resulting in negative impacts on a person's quality of life. The SVPI highlights the societal and community pain rooted in systemic and structural inequalities that affects the quality and standard of living for all. However, the magnitude and severity of this type of community distress disproportionately impacts the most marginalized and under resourced communities in our region. It is undoubtedly clear that a high percentage of people and communities in Santa Clara and San Mateo Counties are feeling some sort of *pain* that is affecting their overall

wellbeing. We know, now more than ever, that it will take cross-sector collaboration to make gradual changes in alleviating the pain in our region.<sup>8</sup>

The five previously published reports have all illustrated persistent (and in many cases expanding) inequality in employment, education, housing, population health, and overall well-being. Over the past year, there have been improvements in some areas, including:

- The use of force incidents in the San José Police Department continues a downward trend<sup>9</sup>.
- The continued expansion and utilization of services to prevent homelessness and support housing assistance<sup>10</sup>.
- Environmental sustainability efforts through investments in tree planting to expand shade canopies<sup>11</sup> and the reduction of carbon dioxide emissions<sup>12</sup>.

Additionally, we acknowledge the efforts of our locally elected officials endorsing promising legislative action to address some of the foundational issues highlighted in the report, such as:

- SB33 (Dave Cortese) guaranteed income for unhoused high school seniors<sup>13</sup>
- SB685 (Dave Cortese) pilot program covering full cost of college attendance (at select universities) for unhoused youth<sup>14</sup>.
- AB3229 (Alex Lee) pilot program to increase fruit and vegetable consumption among CalFresh recipients<sup>15</sup>.

However, the 2025 SVPI includes new data showing the continued growth in local disparities and widening gaps in wealth affecting all aspects of life in Santa Clara and San Mateo counties.

## How to read the SVPI

The 2025 Silicon Valley Pain Index is composed of more than 200 statistics drawn from hundreds of sources. The data were obtained from public records and databases, published reports, and research conducted in or about Silicon Valley over the past year. The 2025 statistics are presented chronologically from the smallest to the largest number and are designed to be read from start to finish, emphasizing the dramatization of inequality as the numbers steadily increase.

Readers should observe the trends and consistencies in the inequalities presented in the report, particularly among specific population demographics (e.g., African American, Latine/x, Indigenous) and communities (e.g., East Side San José). It is clear, there are many receiving considerably less of the economic, political, educational, social, and health-related rewards offered in Silicon Valley.

- 20 Percent of Santa Clara County adults who provided unpaid care to another adult.<sup>60</sup>
- 20 Number of superfund sites located in Silicon Valley (Santa Clara and San Mateo County), primarily located in lower income areas.<sup>61, 62</sup>

- 25.5 Rate per 100,000 of new HIV cases among Latino men, more than two times the county-wide rate (10.4/100,000).<sup>69</sup>
- 26 Percentage of Latino Silicon Valley residents were concerned about legal status, an increase of 8% from 2018. The majority (54%) reported those concerns prevented the use of health care services (48%), accessing health insurance (46%), and getting or keeping a job (42%).<sup>70</sup>
- 26 Percent of newly reported HIV cases in San Mateo County who were late testers in 2023, an increase from just 16% in the previous year.<sup>71</sup>

- 26.1      Percent decrease in students who met UC/CSU requirements in the San José Unified School District. Slightly more than a quarter (28.6%) of Black students and 31.6% of Hispanic and Latino students met the requirements in 2023-2024.<sup>72</sup>
- 27        Percent of Latino residents who reported unstable housing.<sup>73</sup>
- 27        Percent of Silicon Valley Latinos who did not have a high school diploma compared to 6% for non-Latinos in 2023.<sup>74</sup>
- 28        Percent of Latino third graders who met or exceeded the English standards, compared to 79% of Asian students.<sup>75</sup>
- 29.97    Age-adjusted rate of Chronic Obstructive Pulmonary Disease (COPD) emergency department visits per 10,000 among Black/African Americans aged 25 and older in San Mateo County in 2023, a rate more than 4 times higher than Asian American residents (7.2/10,000).<sup>76</sup>
- 30        Percent of unhoused single mothers with children living along San José city waterways.<sup>77</sup>

- 42 Number of traffic fatalities among unhoused individuals in San José, with the highest number reported in Council District 7 between 2018 and 2022.<sup>98</sup>
- 42 Number of homes in Santa Clara County that sold between \$500-749,000 in 2024, a decrease from 3,702 in 2014.<sup>99</sup>
- 43.8 Percentage of students in San José Unified School District who were socioeconomically disadvantaged (2024).<sup>100</sup>
- 44 Percent of residents who considered extreme weather as serious problem, a 5% increase from 2023 (39%).<sup>101</sup>
- 44 Percent of Silicon Valley residents reported not being able to consistently afford their monthly expenses with enough left over for savings.<sup>102</sup>
- 45 Percent of renters who were housing burdened (spending more than 30% of gross income on rent).<sup>103</sup>
- 45.7 Percent of drug overdose deaths among the Santa Clara County white population (30.7% of the overall population).<sup>104</sup>

- 46.35 Age-adjusted rate of asthma emergency department visits per 10,000 among Black/African American's aged 25 and older in Santa Clara County in 2023 compared to Asian Americans at just 6.77 per 10,000.<sup>105</sup>
- 50 Percent of those who transitioned to permanent housing with the help of subsidized housing in 2024.<sup>106</sup>
