# Decision Makers on the Hill

#### House Committee on Ways and Means

jurisdiction over taxes & other revenue-raising measures, tariffs, reciprocal trade agreements, and U.S. bonded debt

#### Senate Committee on Finance

deals with matters relating to taxation and other revenue matters

#### House Agriculture Committee

jurisdiction of ag policy and oversight of Commodities Futures Trading Commission (CFTC)

#### Senate Committee on Ag, Nutrition & Forestry

oversight of the nation's ag industry and policy including the CFTC

#### House Financial Services Committee

jurisdiction over the economy, banking system, housing, insurance, and securities and exchanges

#### Senate Banking Committee

 covers a variety of banking activities including securities, financial markets, and economic policy



# What to Expect in 2025 and the Budget Resolution Timeline

**Weeks of Jan. 13 & 20**: Listening sessions, member feedback, coordination with Senate

Week of Jan. 27: "Final decisions" and "drafting"

**Week of Feb. 3**: Budget resolution released, House Budget Committee to mark up

Week of Feb. 10: House floor consideration

Week of Feb. 17: Senate floor consideration

Week of Feb. 24: Final House consideration if Senate makes changes.
